### Theme

Films can be of any genre, topic or theme. Films must have been made in the past two years to be eligible for entry and comply with the other conditions of entry.

### Length

Films need to be between 1 and 8 minutes in length.

### Format

Films will be required to be uploaded by the film maker to Vimeo (we will email you details about how to do this once we receive your application).

### Award Categories

There are three categories: **School Age** (you have to be attending a secondary school) **Novice** and **Open** section. To classify as a Novice entry, the film maker must not be attending a secondary school, and have publicly shown no more than two of his/her film productions.

### Judging Criteria

1. Creativity
2. Originality
3. Technical execution
4. Subject matter / screenplay
5. Overall impression.

### Screening

The judges top 10 films will be shown on the opening night.

### Presentation of Awards

Prizes and awards will be presented at the conclusion of the initial screening. They will include 'People's Choice' and 'Best Local Film'.

**Closing Date:** Finished product must be submitted by **10.00 pm, Friday May 6<sup>th</sup> 2016.**
